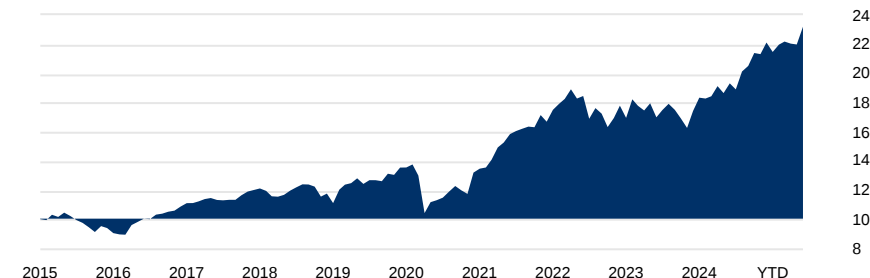

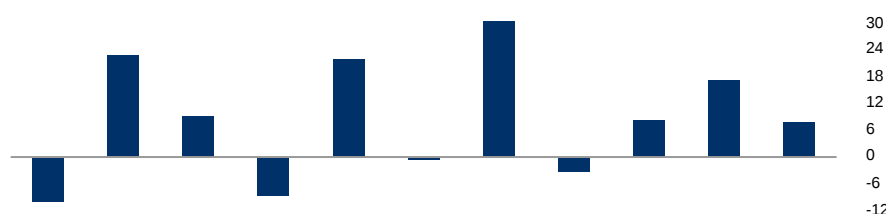
## Performance analysis for Series D as of May 31, 2025

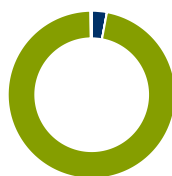
