Investment objective

To provide long-term returns consisting primarily of interest income and moderate capital growth. The Fund invests primarily in investment grade fixed-income securities issued by Canadian corporations. It may also hold similar securities of U.S. corporations.-In constructing the portfolio, the investment team considers the direction of interest rates in Canada, the U.S. and other major economies. The expected changes in interest rate spreads between and within different segments of the market (e.g. federal, provincial and corporate) are also considered. The Fund can hold up to 20% in debt rated below BBB, but the average credit quality of the Fund cannot fall below BBB.




