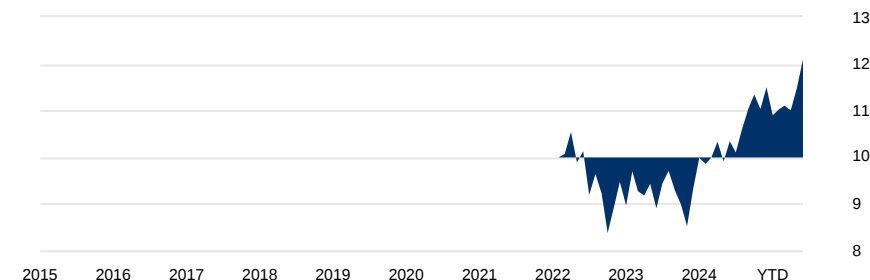

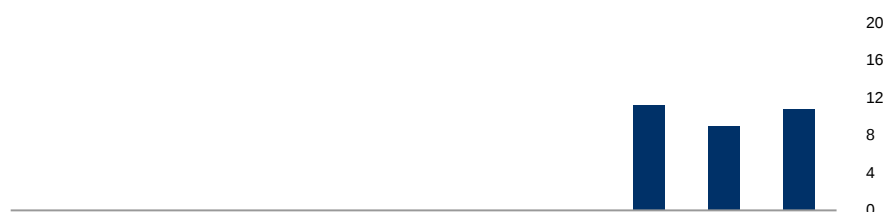
Performance analysis for Series F as of May 31, 2025

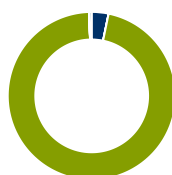
