The Carbon Underground 200 represents the top publicly-traded coal, oil, and gas reserve-owning companies globally, ranked by the carbon emissions potential of their reported fossil fuel reserves.

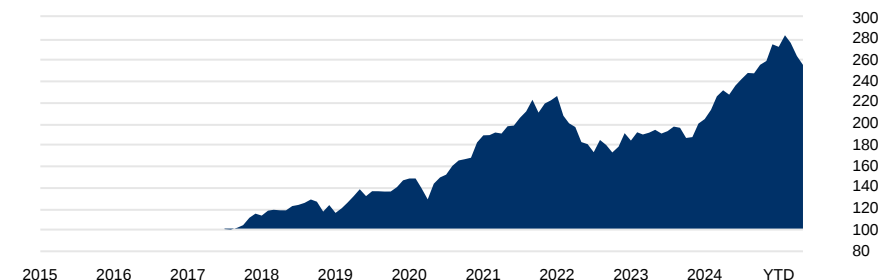

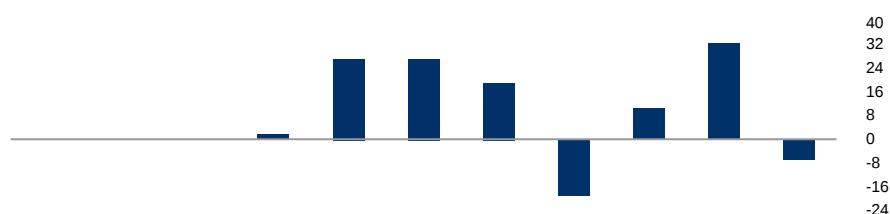

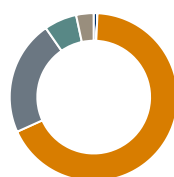
