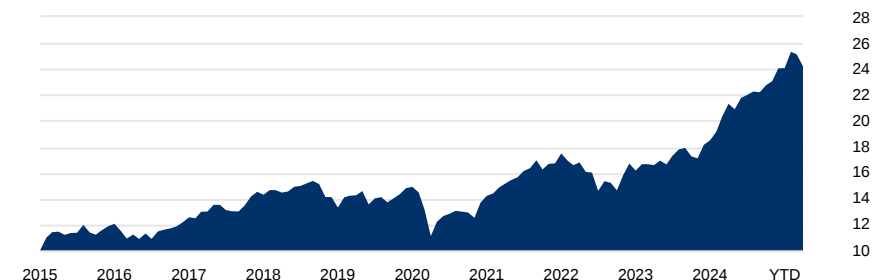

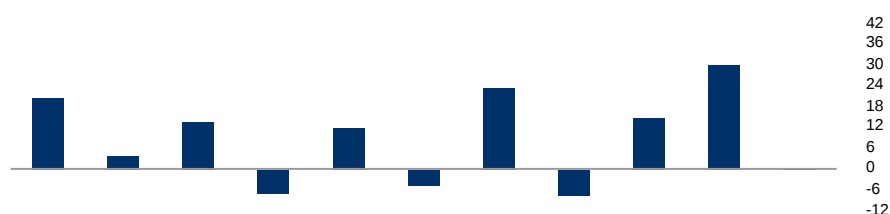
Performance analysis for Series D as of March 31, 2025

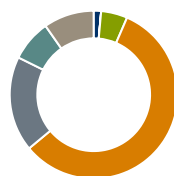
