## RBC O'Shaughnessy U.S. Value Fund (Unhedged)




### Investment objective

Strategy Indexing is a rigorous and disciplined approach to stock selection based on characteristics associated with above average returns over long periods of time. Stocks, including American Depositary Receipts (ADRs), are bought and held over the course of each year, with no attempt to "time the markets".
