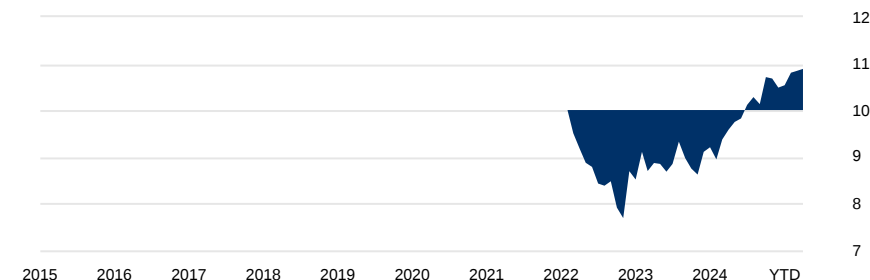

100% MSCI Emerging Markets Investable Market Net Index (CAD)

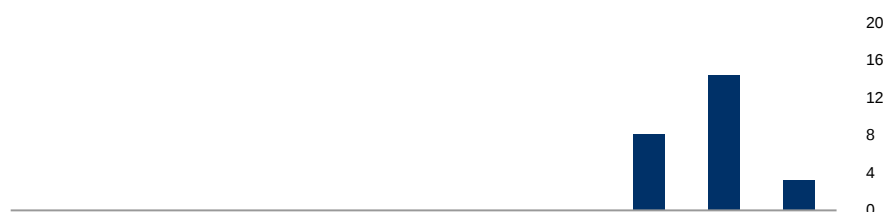

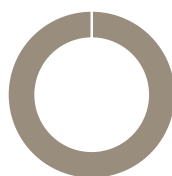
