# RBC Target 2028 Canadian Corporate Bond Index ETF





## Investment objective

Provide income for a limited period of time ending on its termination date by replicating, to the extent possible, the investment results that correspond generally to the performance, before fees and expenses, of the FTSE Canada 2028 Maturity Corporate Bond Index. The FTSE Canada 2028 Maturity Corporate Bond Index is designed to represent the performance of a held-to-maturity portfolio consisting of, primarily, Canadian dollar-denominated investment grade corporate bonds with effective maturities in 2028. It is anticipated that the ETF will terminate on or about September 30, 2028.

### Reasons to invest


- Invests in a portfolio of Canadian corporate bonds, with laddered maturities from 1-10 years

- Combines short-term and medium-term bonds while seeking to mitigate overall risk


