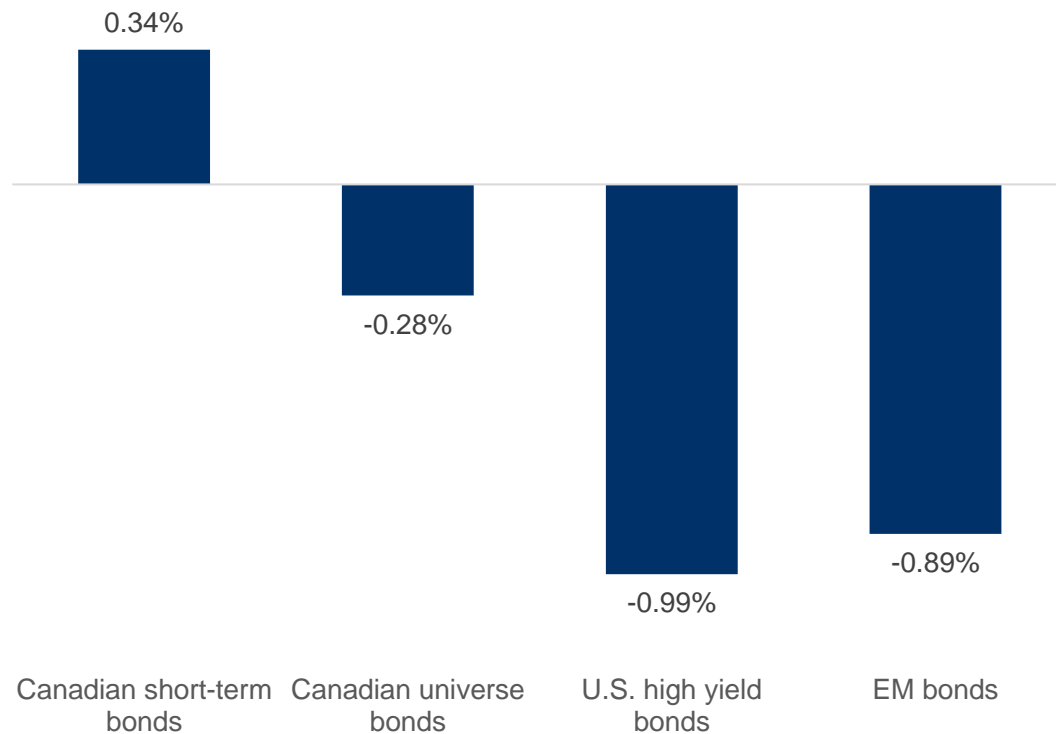

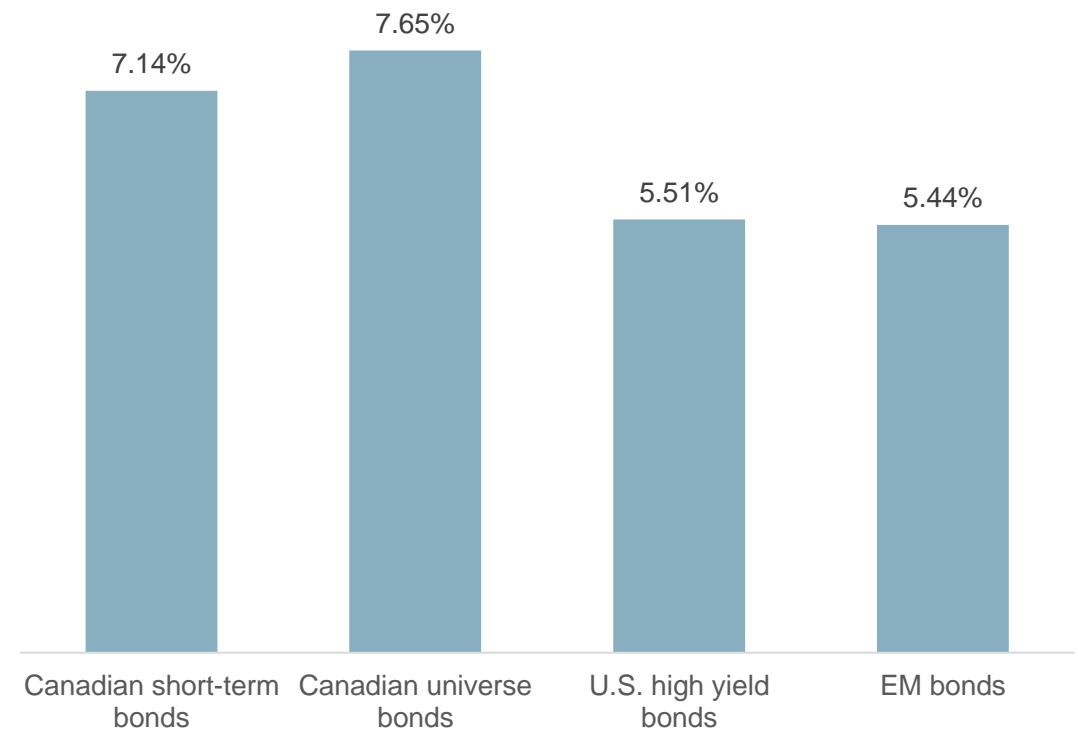

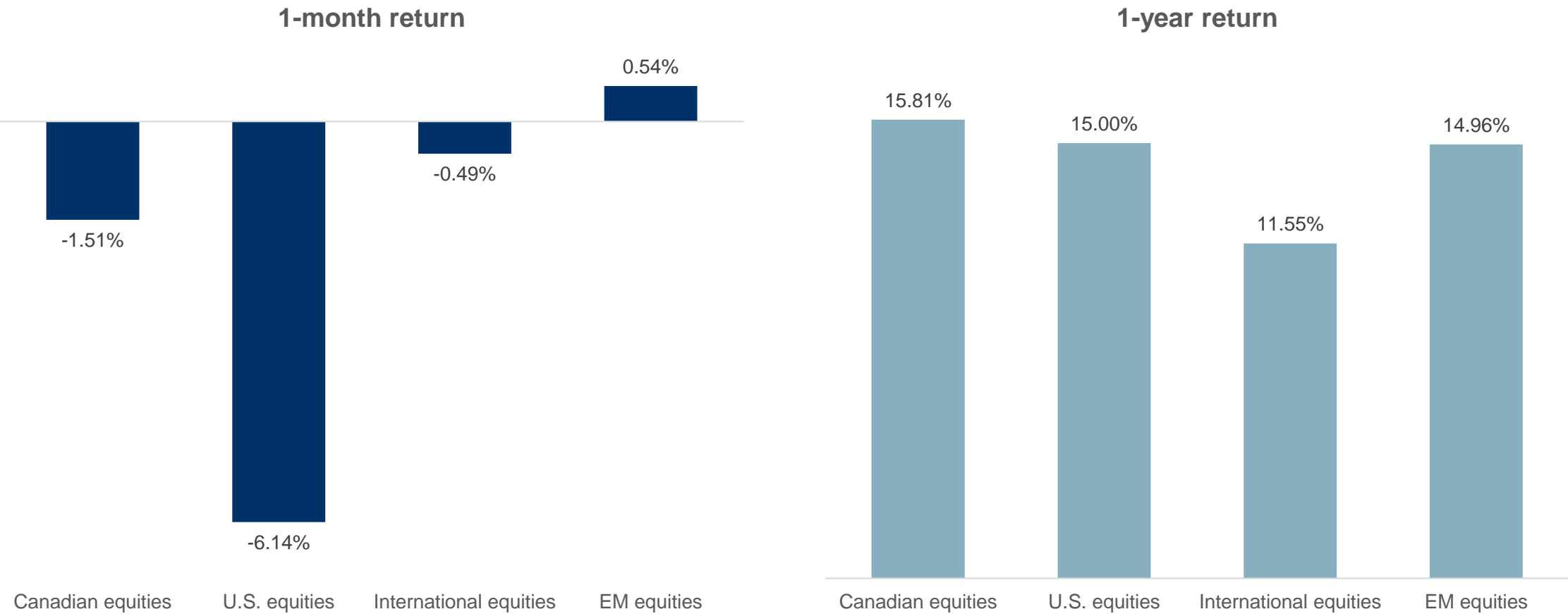


1-year return

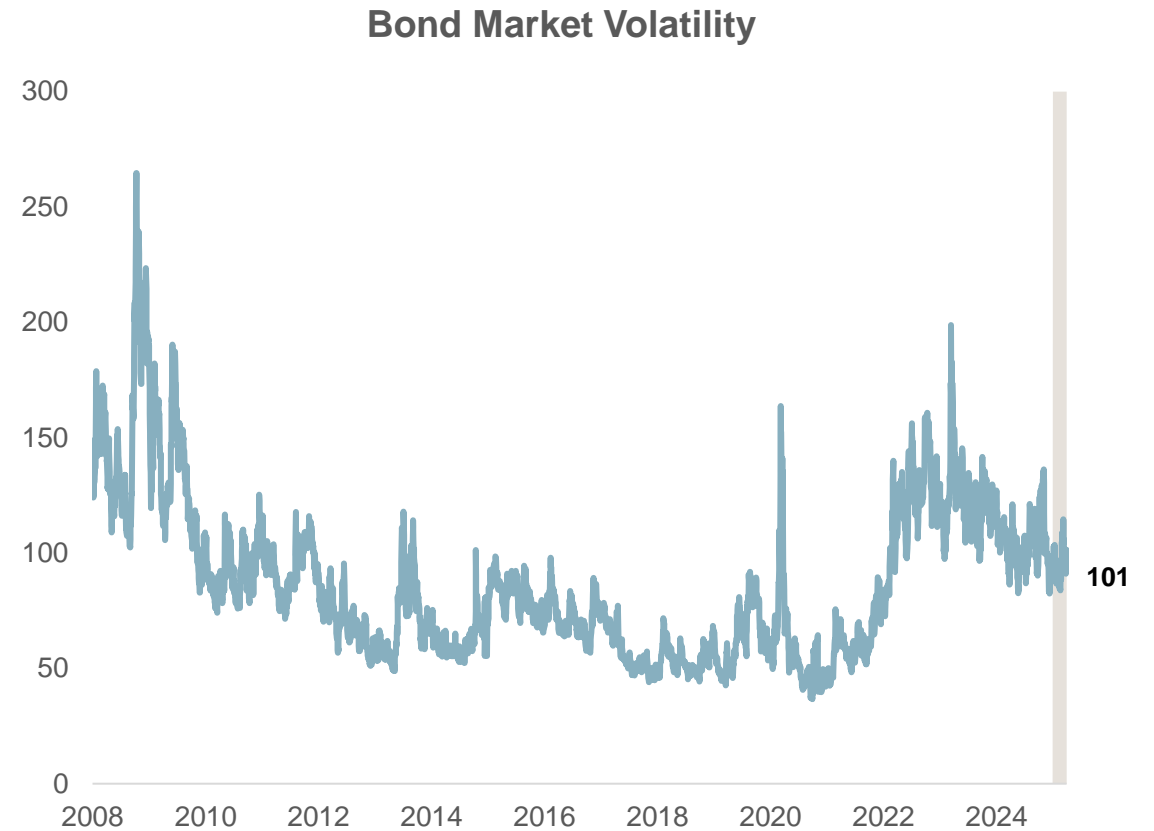
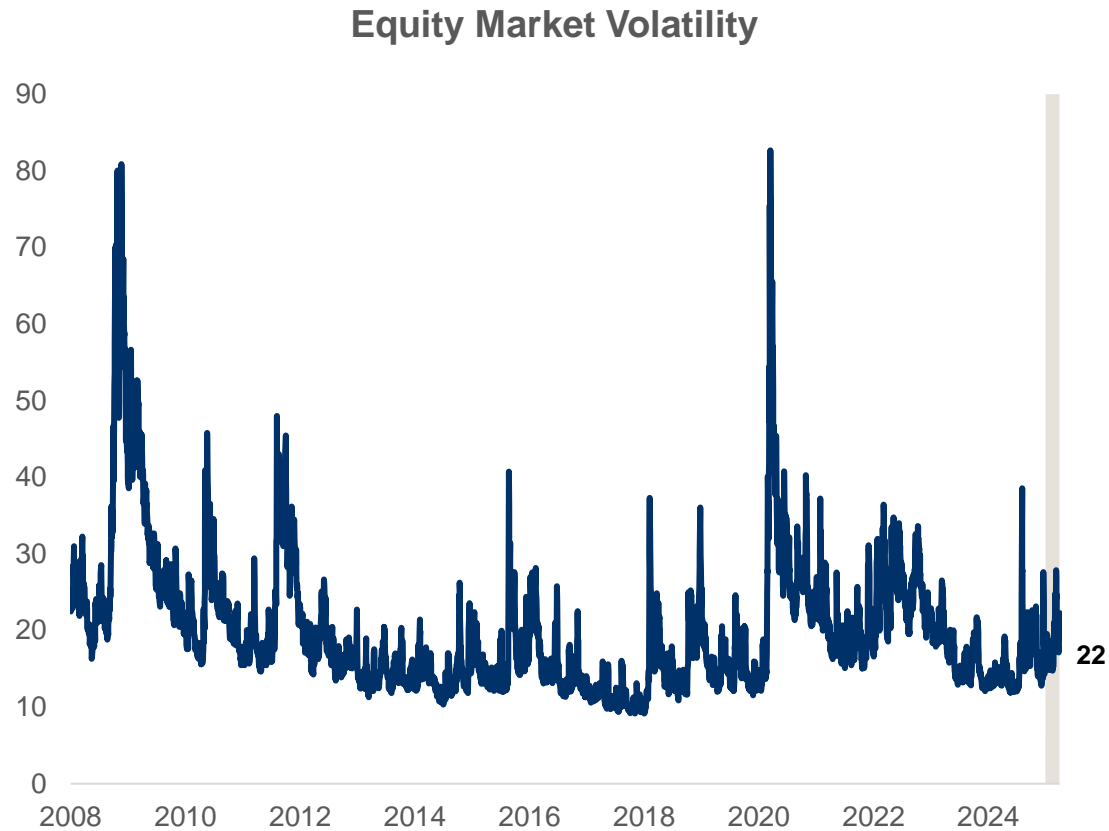

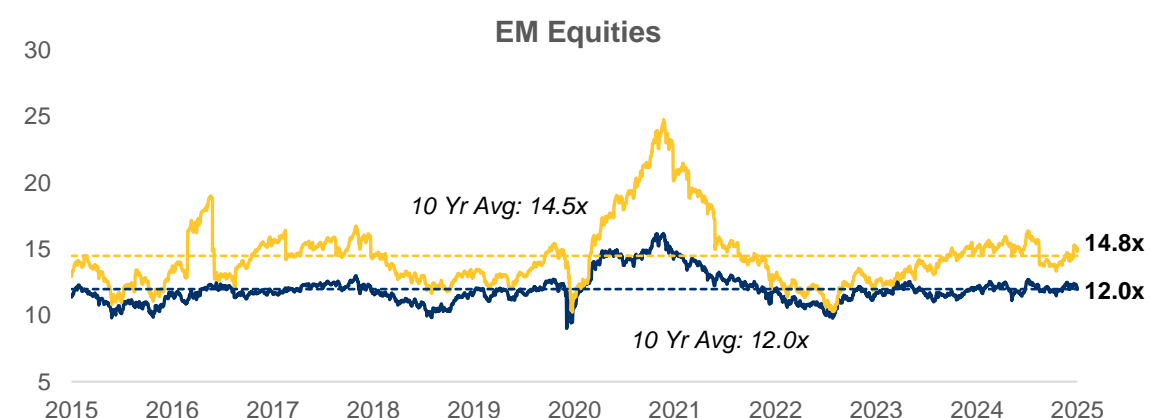
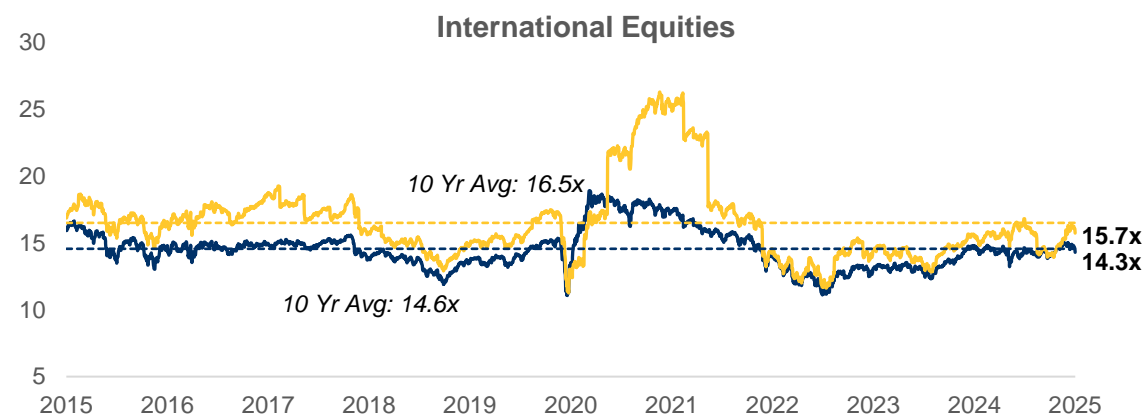
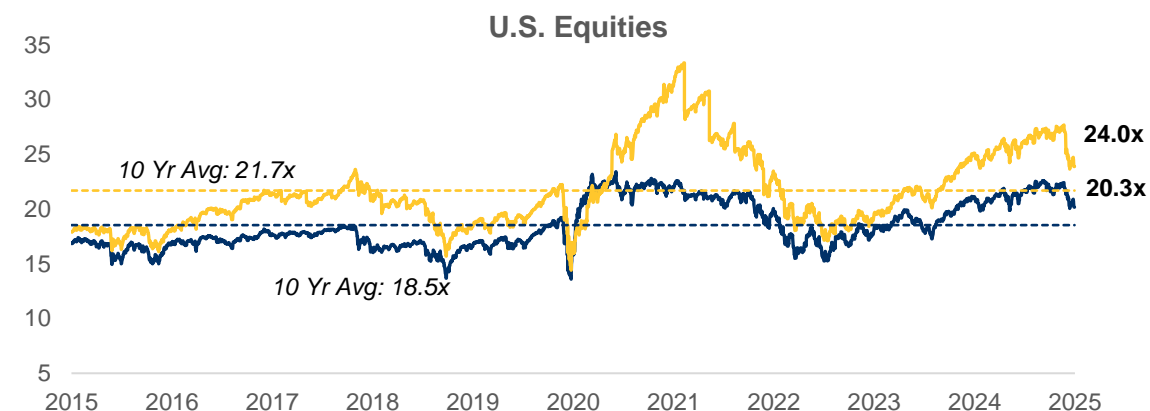
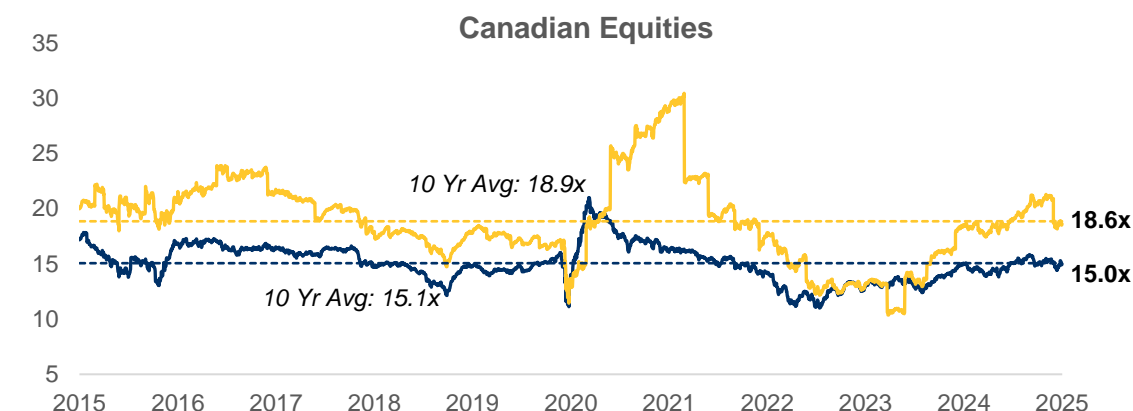

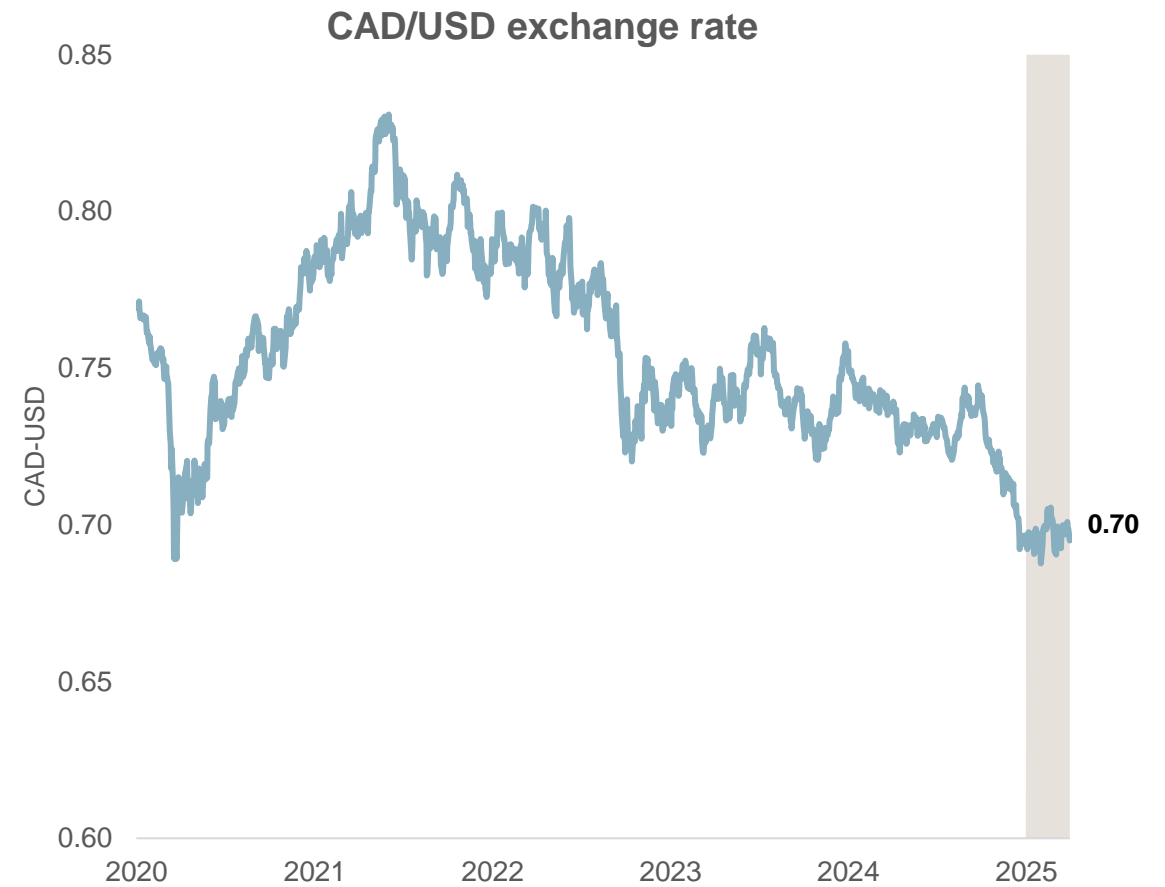


Trailing P/E Ratio

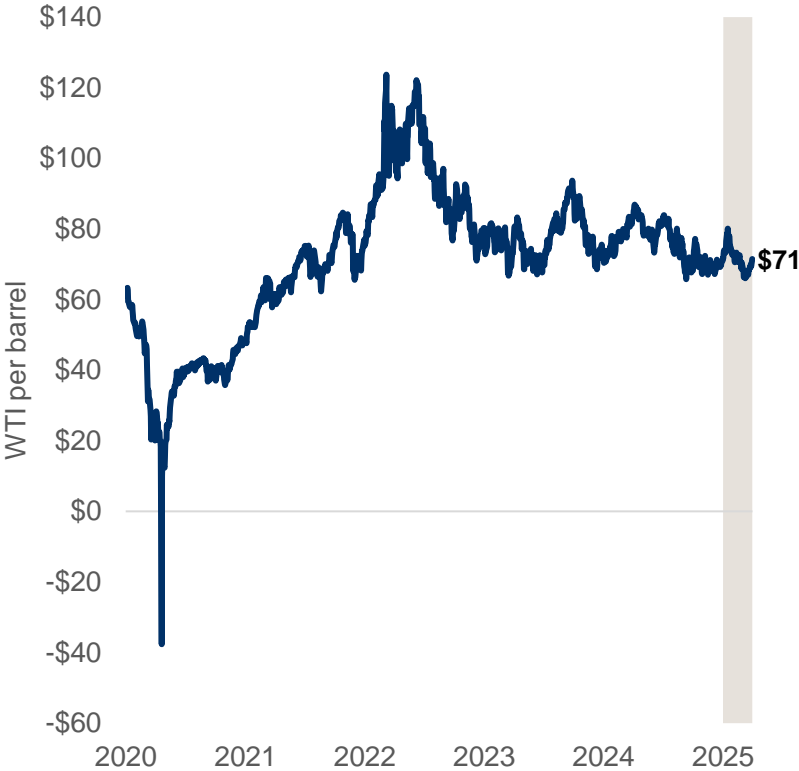

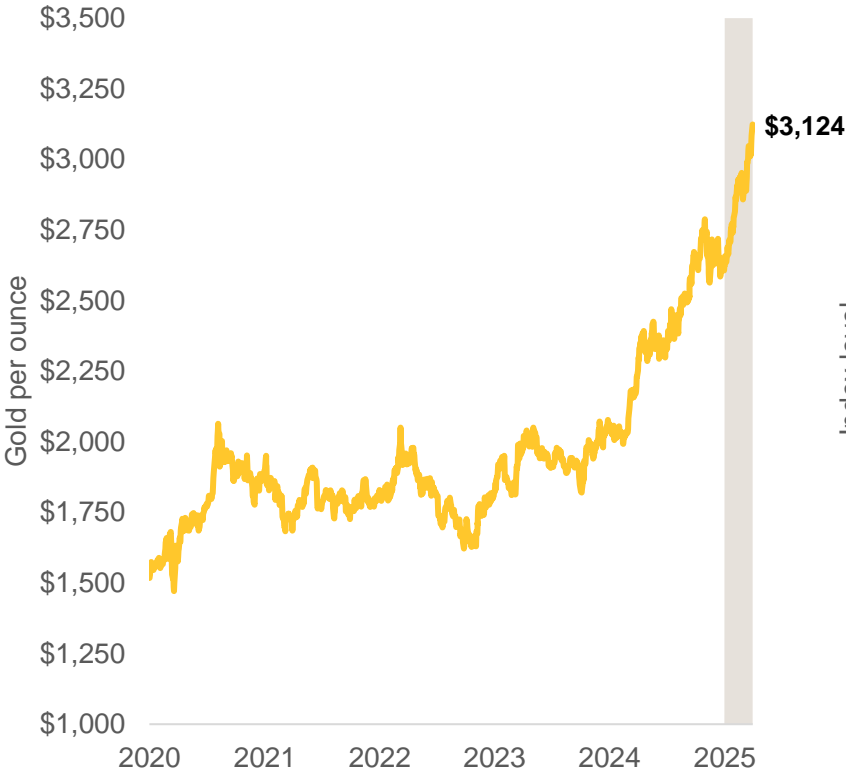
