This Amendment No. 2 dated April 8, 2020 to the simplified prospectus of the Fund dated June 27, 2019, as amended by Amendment No. 1 dated July 10, 2019 (the "Simplified Prospectus") provides certain additional information relating to the Fund. The Simplified Prospectus with respect to the Fund should be read subject to this information. All terms used and not defined in this Amendment No. 2 have the same meaning as those used in the Simplified Prospectus. All page numbers refer to the pages in the commercial printed copy of the Simplified Prospectus.

### Summary

RBC Global Asset Management Inc. has announced that Series A, Advisor Series, Series D, Series F and Series O units of the Fund are reopened to new investors effective April 6, 2020.

### Amendment

Effective April 6, 2020, the Simplified Prospectus is hereby amended as follows:

- 1. The *Fund details* table on page 28 of the Simplified Prospectus is amended by (i) deleting note 2 (as added by Amendment No. 1 dated July 10, 2019) in its entirety, (ii) redesignating note 3 as note 2 and (iii) replacing the current reference to note 3 in the *Management fee* column in the fifth row *Fees and expenses* with a reference to note 2.
- 2. The second paragraph under the heading *Restrictions on purchasing units of certain Funds* on page 119 of the Simplified Prospectus (as added by Amendment No. 1 dated July 10, 2019) is deleted in its entirety.

### What are your legal rights?

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days of receiving the Simplified Prospectus or fund facts, or to cancel your purchase within 48 hours of receiving confirmation of your order.

Securities legislation in some provinces and territories also allows you to cancel an agreement to buy mutual fund units and get your money back, or make a claim for damages, if the Simplified Prospectus, annual information form, fund facts or financial statements misrepresent any facts about the Fund. These rights must usually be exercised within certain time limits.
