This Amendment No. 1 dated July 14, 2022 to the simplified prospectus of the Fund dated June 27, 2022 (the "Simplified Prospectus") provides certain additional information relating to the Fund. The Simplified Prospectus with respect to the Fund should be read subject to this information. All terms used and not defined in this Amendment No. 1 have the same meaning as those used in the Simplified Prospectus. All page numbers refer to the pages in the commercial printed copy of the Simplified Prospectus.

Summary

RBC Global Asset Management Inc. has announced that Series A, Series D, Series F and Series O units of the Fund are reopened to new investors effective July 12, 2022.

Amendment

Effective July 12, 2022, the Simplified Prospectus is hereby amended as follows:

1. The second paragraph under the heading *Restrictions on purchasing units of certain Funds* on page 21 of the Simplified Prospectus is deleted in its entirety.
2. The *Fund Details* table on page 75 of the Simplified Prospectus is amended by (i) deleting note 2 in its entirety, (ii) redesignating note 3 as note 2, and (iii) replacing the current reference to note 3 in the *Management fee* column in the fifth row (*Fees and expenses*) with a reference to note 2.

What are your legal rights?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual funds within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours of receiving confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase or, in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limits set by law in the applicable province or territory.
