

Portfolio manager viewpoint

Sarah Riopelle, CFA, Managing Director, Senior Portfolio Manager & Head of Portfolio Solutions and Platform Talent

Our base case is for the economy to grow at a modest pace, though we recognize that there is significant uncertainty from tariffs. Bonds offer decent return potential and an important ballast against equity-market volatility, especially in this environment. We added 50 basis points to bonds, sourced from cash earlier in the

year when the U.S. 10-year yield climbed over 4.60% then reversed that trade after the latest rally. We reduced exposure to North American equities in favour of international and emerging market stocks as valuation risk is concentrated in U.S. equities. Recently, the premium between stocks and bonds improved as market weakness addressed some of the valuation risk. As a result, we added one percentage point to our equity position from cash, moving off neutral to a slight overweight. Volatility will likely remain for some time and we will continue to look for opportunities to adjust our exposures as events unfold.
