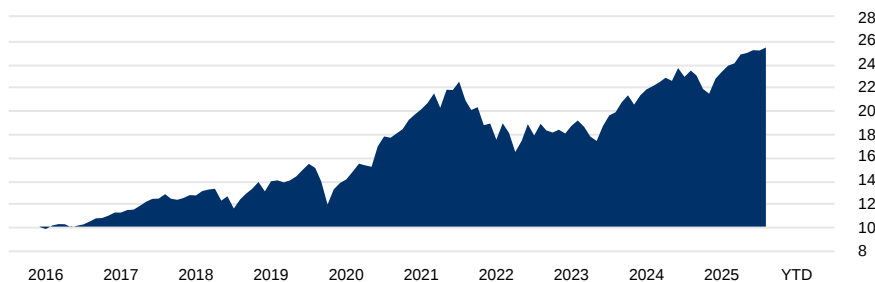

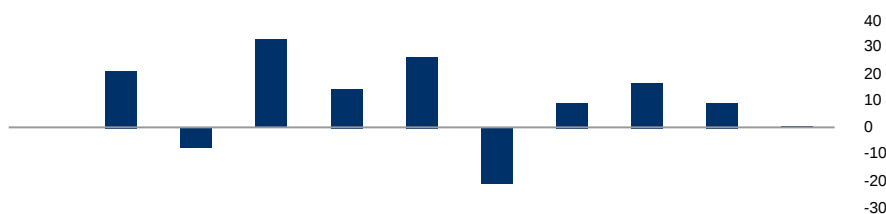
Performance analysis for Series A as of January 31, 2026
